This year we were also able to add a Family Law Advocate to our team. There is a great need for support for individuals on low incomes in accessing family law services. Our new Family Law Advocate will help in meeting this need.

This past year of change and growth has been exciting and we look forward to the years ahead as we work to improve services for women and families in Kamloops.

FSS Update

Family Stepping Stones was established in 2015 and is the first Women's Second Stage Housing Program in Kamloops. Our participants are women in recovery who have experienced intimate partner violence, and have expressed a need for support in rebuilding their lives.

Family Stepping Stones second stage housing offers women two years of safe affordable housing and an opportunity to work towards goals identified upon entry into the program. Goals are assessed each week through our weekly check-ins and goal tracking where we support women with issues such as remaining free of substance misuse, regaining custody of their children, financial management, retraining, and strengthening parent-child attachment through parenting supports.

During 2018-2019 the Family Stepping Stone program witnessed 4 families graduate and transition into

subsidized housing. We also want to thank Flaman Fitness for the donation of this wonderful play area for the participants at Family Stepping Stones.



Legal Aid and the Advocates (Poverty Law and Family Law) are now located at: #702-235 1st Avenue, in the beautiful Downtown Centre.




Family Law Advocacy Program

WE HAVE A NEW PROGRAM!

The Family Law Advocacy Program provides free legal information and advocacy in a variety of areas, including Guardianship and Parenting time, Parental Responsibilities, Child Support, Spousal Support, Divorce, Protection Orders and Child protection. The advocate aids in the preparation of certain court documents and can help clients represent themselves in court proceedings. The Legal Advocate works under the supervision of a Lawyer and can provide referrals to other community resources when necessary. The Family Law Program is open to anyone with a low income living in Kamloops, Ashcroft, Barriere, Cache Creek, Chase, Clearwater, and the Secwepemc First Nations' communities.


Rent Bank Update


During the 2018/2019 year our Rent Bank gave out 19 loans. 1/3 (6) of them were repaid within the same year. 16 of the 19 loans were to single income women with children and 3 single men without children. This shows that there is a significant demand on single moms to meet the needs of their families in our community.

"I am a mature single mother, a full-time student at the university, I work a part time job along with working odd jobs to make ends meet. I made the decision to finish my degree because my full-time job did not financially cover the cost of my family's basic necessities. My situation is not uncommon. The Rent Bank provides a functional option during challenging months. Not only has the Rent Bank allowed my family to remain housed and safe, but this resource provides me a sense of emotional security positively affecting my family's well-being. I believe a community that supports its members will see the trickle-down benefits which ultimately pays out in dividends. My family is grateful. Thank you." - Anonymous


